

**Legal Proceedings of the City of Fox Lake  
Common Council  
September 1, 2021**

The regular meeting of the City of Fox Lake Common Council was held on Wednesday, September 1, 2021, at 6:30 p.m., in the council chambers. The meeting was called to order by Mayor Tom Bednarek and followed by the pledge of allegiance. Roll call was taken with alderpersons Dan Ault, John Mund, Peter Hartzheim and Dennis Linke present. Marcy Benz and Don Zilewicz were absent. Also attending were Police Chief James Rohr and City Clerk Jenny Quirk.

In the audience were Darrell Pollesch and Lynn Swiggum.  
The clerk certified open meeting laws have been complied with.

**Public comments:**

Lynn Swiggum presented concerns on the cemetery caretaking. The Mayor stated he would provide the information to DPW to look into. Lynn Swiggum also presented concerns regarding the placement of her neighbor's fence alongside her property. The Mayor instructed her to speak with the building inspector.

**Approve minutes:**

Motion by Linke, seconded by Mund to approve the minutes of the August 18, 2021 special council meeting. Motion carried with a voice vote.

**Consent Agenda:**

Motion by Linke, seconded by Hartzheim to approve the consent agenda, as listed below:

- a. Pay the bills, as audited, for accounts payable-check #42116 through #42211 totaling \$208,349.26 (including ACH withdrawals) and payroll checks #60401 through #60444 checks totaling \$37,665.68. Vote in favor: Hartzheim, Linke, Mund and Ault. Motion carried.

**Fox Lake Wastewater Control Commission appointment:**

Motion by Mund, seconded by Ault to approve the Mayor's appointment of Dennis Linke to the Fox Lake Wastewater Control Commission for a term of 3 years, ending August 2024. Motion carried with a voice vote.

**Resignation of Don Zilewicz from 1<sup>st</sup> Ward Alderperson seat:**

Motion by Mund, second by Hartzheim to accept the resignation of Don Zilewicz from 1<sup>st</sup> Ward Alderperson as of August 31, 2021. Motion carried with a voice vote.

**Appointment of Darrell Pollesch to vacant 1<sup>st</sup> Ward Alderperson seat:**

Motion Hartzheim, seconded by Mund to recommend the appointment of Darrell Pollesch, as of September 1, 2021, to the vacant 1<sup>st</sup> Ward Alderperson seat, to complete the remainder of the term ending in April 2022. Vote in favor: Hartzheim, Linke, Mund and Ault. Motion carried.

**Lease agreement 210 Trenton St. #1:**

Motion by Mund, seconded by Linke to approve the lease agreement of 210 Trenton St. #1, Fox Lake; between the City of Fox Lake and Jay Schraufnagel effective as of September 1, 2021. Vote in favor: Linke, Mund, Ault and Hartzheim. Motion carried.

**Question and Answer with Senator Joan Ballweg:**

Senator Joan Ballweg provided a handout to the Council showing updates relating to the state budget, transportation, and redistricting.

With no other business to come before the Council, motion by Linke, seconded by Hartzheim to adjourn. Motion carried with a voice vote. Meeting adjourned at 7:20 p.m.
